EARNED INCOME CREDIT AMOUNT INCREASE

You have three or more qualifying children and you earned less than \$48,340 (\$53,930 if married filing jointly). The maximum credit is \$6,318.

You have two qualifying children and you earned less than \$45,007 (\$50,597 if married filing jointly). The maximum credit is \$5,616.

You have one qualifying child and you earned less than \$39,611 (\$45,207 if married filing jointly). The maximum credit is \$3,400.

You do not have a qualifying child and you earned less than \$15,010 (\$20,600 if married filing jointly). The maximum credit is \$510.

PERSONAL EXEMPTION

The personal exemption amount for 2016 is \$4,050.
